Abin is Executive Vice President of Innovation & Venture Strategy at World Business Chicago, the City of Chicago's economic development organization chaired by the Mayor. He currently serve as a member of Chicago:Blend's advisory board, mHUB's community impact advisory committee, and the State of Illinois' Asian American Employment Plan Advisory Council.

There was a suggestion that there be an annual directory of members, towns, emails and term years as that information is helpful to communicate with each other. This could be opt in/out.

The website will be updated to reflect terms and community designations and the sharing of emails will be addressed.

Alison shared that in addition to members renewing their terms and identifying Designated Community Representatives, Fermilab will be making a broad request later this year for new members. Q – How is a Designated Community Representative decided?

A – We work with the mayor's office to have someone specifically appointed for a community. Up to now the board has primary been an application process. The community representative has been happening for a while with Warrenville very successfully and we wanted to expand that. If the Designated Community Representative decides to leave the CAB, a new person will be appointed by the mayor's office. We want to make sure we have those touchpoints with each community to hear questions and concerns and the mayors' offices hear announcements.
