Fermilab Site Access: Now and in the Future



Background

Fermilab operates the largest accelerator complex in the United States. As one of 17 Department of Energy (DOE) laboratories, Fermilab needs to comply with safety and security regulations that will protect everyone who works at or visits the Fermilab campus. To be in compliance, Fermilab needed to change some of its site access policies and is currently working with the DOE and an internal task force on ways to balance its open, welcoming culture with the need to protect both its people and its assets.




Anticipated Site Access 2023 – early 2025

Fermilab will be upgrading badging systems to improve access to Wilson Hall (2023-2024), and build a Welcome & Access Center expected to be complete in 2025. With Real ID-compliant identification, Fermilab visitors can access:

- Bison-viewing area
- Restored prairie trails

- On-leash dog walking

- Saturday Morning Physics and other STEM activities in the Ramsey Auditorium
- SAGE summer camp (HS girls)
- Field trips
- MakerSpace programming: STEM spotlight

What have we accomplished so far?

- Established a SAB Task Force in the fall 2022, includes employees & users recently appointed new lead Matt K.
- Improved on access deficiencies identified internally and by the DOE
- Physical access process improvements and transition to Real ID
- Site Access Coordinators established and being trained
- Continuous Badging IT process improvements since 2019
 - 1. Multiple institutions/affiliations tracking
 - 2. DOE upload enhancements
 - 3. FNAP and Export control process enhancements
- Additional support external & internal communications
 - Engaged Communications Division
 - Comprehensive communications plan
 - Successful CAB engagement

New main entrance access

- The new center will provide business visitors and the public with a welcoming entrance to Fermilab
- A smoother administrative process
- Public visitors can obtain visitor passes to visit the public areas of the campus

- The center will provide a place for business visitors to complete any required access forms
- We expect construction to start this fall or in 2024.
