CAB update

- Give enough advance notice for meeting to be advertised (in Warrenville, the library newsletter goes out only quarterly with announcements)
- Attendees supported the idea of getting more communities involved and reaching a larger audience.
- Britta McKenna offered to host pilot offsite CAB meeting at Batavia City Hall, televised by Batavia TV.

Other comments relating to the CAB Meetings:

- Consider revisiting meeting start time commute from work is issue if start time changed to earlier than 6:30 p.m.
- A member of the CAB encountered an issue during winter when leaving the site after nightfall (they leave by East gate, and there were insufficient street lights). GPS was not helpful in navigating, as not all Fermi buildings show up on google maps, and they became lost trying to exit the site.
- CAB meeting cadence should be reconsidered; a suggestion was made to move to quarterly. If someone misses one CAB meeting, given the quarterly cadence, it may be a significantly long time until they are back in the loop again. Is bi-monthly still sufficient?

- New Tritium Management Dept (2023) and Tritium Task Force
- Levels were, and continue to be, well below already conservatively protective regulatory limits.
- Discharge of tritiated water is going down despite higher beam use due to newer measures to exclude water from accelerator area so it cannot become tritiated.
